ABOUT THE BRAND

Cell & Gene Therapy Review is an official brand of CompareNetworks and includes a print magazine, website, digital editions, e-newsletter and social media. The quarterly print magazine is available by subscription to qualified professionals in North America, free of charge. CGTR features content for professionals interested in unbiased and applicable information focused on R&D through manufacturing and packaging of cell and gene therapies.

CONTENT: All articles submitted to CGTR must be:

- Non-promotional — Authors may refer to individual products/processes generically if it is essential to support the technical content of the text.
- Original, having not been published elsewhere. All submissions are screened for plagiarism.
- Consist of no more than 10% of content derived or created by a generative AI tool and this should be disclosed to the editor upon submission.

CONTENT TYPES:

- Articles (print and/or online)
- Columns (shorter pieces, more op-ed tone)
- New products (print only; 100-word write-ups and images for new technologies)

SUBMISSION: Articles/columns should be submitted via e-mail as a Microsoft Word attachment. Please include, author names, job titles, and affiliations at the beginning of the document. A brief (50-75 words) biography should be included for all authors. A print-quality photograph of the author(s) may be submitted as desired.

Articles must be submitted with both a full title and deck (sub-head).

FIGURES/GRAPHS: Figures, graphs or photographs should be supplied as separate high-resolution jpg, pdf, or tiff files. Tables, charts, graphs should be submitted as editable files

in their source program (Word/Excel/PowerPoint). Authors should indicate proper placement of figures within an article by pasting a copy of the figure in the appropriate place in the body of the text. Figures and graphs should also be cited in the text in the order in which they appear.

LENGTH: Submission length may vary by type. Columns run 600-700 words. Print feature articles may run 1,500-2,200 words. Online articles are ideally closer to 1,200 words.

EDITING & STYLE: CGTR reserves the right to edit any article as necessary while retaining its original meaning or context. Proofs of edited articles will be sent to contributors for review prior to publishing. CGTR follows AP news style. Articles should be written in a clear, concise and readable tone. Submitting authors bear full responsibility for accuracy of information.

REFERENCES: Authors are responsible for the validity, accuracy and completeness of their references and for correct text citation. References in the reference list should be listed in the order in which they appear in the text. Please also include links when applicable.
